According to the report, a significant area of the land cleared appears to be secondary and young regenerating forests (regrowth forests). Over 24 acres of secondary forests have been cleared, as well as a further 740 acres of young regenerating forests. Subsequently, in Rapid Response Report No.39 in May 2022, Mighty Earth revealed that the concession had been handed over by PT ALM to PT SSS. While PT ALM is a supplier of GAR's, PT SSS is not.
